## **Statement of Accomplishment and Future Research**

Having joined University of Illinois at Urbana-Champaign (UIUC) in 2014, I am currently an Associate Professor at the UIUC School of Social Work. Prior to joining the faculty at UIUC, I completed a 2-year post-doctoral fellowship in cardiovascular epidemiology at Northwestern University Feinberg School of Medicine. I have over a decade of experience in conducting research, teaching at the undergraduate and graduate levels, and in engaging with community partners in Chicago and Urbana-Champaign who predominantly serve Hispanic/Latino adults and other vulnerable populations. My research portfolio focuses on exploring the link between psychological well-being (e.g., optimism) and cardiovascular health (CVH), along with delivery of positive psychological interventions intended to boost emotional assets in vulnerable populations using emergent technology. My work is highly transdisciplinary. We seek to build virtual reality (VR) applications for use in clinical populations and is inclusive of the fields of public health, kinesiology, social work, psychology, nephrology, engineering, graphic design, and theatre, among others. My lab is also working closely with the Gies College of Business and Discovery Partners Institute (DPI) to work toward commercializing our VR technology, by first conducting a customer discovery analysis and developing a go-to-market strategy.

My research program is built around a drive to discover how psychological assets impact heart health, how this knowledge can improve CVH profiles in racial/ethnic minorities and vulnerable populations, and how technologies can be harnessed to hasten dissemination of evidence-based treatments. My funded work investigates these key areas: (1) observational link between psychological assets and heart health, and plausible mechanisms, (2) impact of strengths-based positive psychological interventions on cardiac health in Hispanics/Latinos, and (3) use of innovative technology to disseminate strengths-based psychotherapeutic content. To date, my research has produced 42 peer-reviewed publications (21 of which are first-authored) with impact factors ranging from none to 16.834. Having recently completed a 5-year K01 Career Development award from the National Heart, Lung, and Blood Institute, I successfully transitioned to an R01 grant as principal investigator, where my team secured just under 1million dollars to develop a 5-module VR program to treat depressive symptoms in hemodialysis, chairside while they undergo dialysis. I am also principal investigator for an R21 from the National Institute for Minority Health and Health Disparities and multiple foundation grants, i.e., the Rosenfeld Heart Foundation and Jump ARCHES. I have given over 40 oral or poster presentations at national and international conferences—with significant involvement with the American Heart Association where I am a board member of the LIFESTYLE & EPI Behavioral Change for Improving Health Factors Committee. My findings on the health benefits

of positive psychological assets sparked interest from multiple media outlets (e.g., U.S. News & World Report, NPR, Forbes), including a featured story by the American Heart Association.

I am a recognized national leader in the field of positive psychology, particularly in the integration of cultural adaptions across interventions seeking to promote emotional well-being to address health disparities in cardiovascular health and chronic kidney disease. I am a teaching faculty in the summer short course organized by the Lee Kum Sheung Center for Health and Happiness at the Harvard T.H. Chan School of Public Health and the Research Department of Behavioural Science and Health at the University College London (UCL), where I lecture on the cross-cultural considerations when exploring emotional well-being and health and important consideration when designing positive psychological interventions that use emergent technologies in clinical populations. This requires annual summer travel to UCL. I am also a national leader in the influence of structural violence on health in underserved communities, particularly through my work using data of the largest cohort of Hispanic/Latino adults, i.e., the Hispanic Community Health Study/Study of Latinos. My research portfolio has also allowed for community engagement with immigrant and minority serving organizations in Chicago, including Catholic Charities, Taller de Jose, and the Brighton Park Neighborhood Council, among others. I have partnered with these Chicago-based non-for-profit organizations in multiple capacities, including as a volunteer to help develop process and outcome evaluation plans and metrics and in the design of trials to assess community access to mental health services.

My future work will continue exploring technology to deliver my evidence-based positive psychological intervention in ethnic/racial minorities at risk for cardiovascular disease and adults with kidney disease. My VR software can be easily adapted and translated into many languages with limitless options for cultural tailoring; it also has enormous potential for rapid expansion to other patient populations. In partnership with Illinois CancerCare in Peoria, I am currently collecting pilot data on use of my VR technology in lung cancer patients with the goal of submitting an R01-level grant to the National Cancer Institute (NCI). My work in VR continues to expand. My lab is currently building prototypes to deliver nutrition education to hemodialysis patients and to school-aged children, through a 3D immersive and gamified experience using Oculus technology. Finally, I want to test strategies for implementation of my technology-enhanced positive psychological interventions at the population level in order to improve access to care and reduce disparities in the burden of disease among vulnerable populations.

## **Commitment to Teaching and Student Mentorship**

My teaching approach is informed by Paulo Freire, who contends that students should go beyond the banking concept of education where simple rote memorization is espoused. Instead, I seek to foster emergence of critical thinkers who grapple with real-world social problems and who are subsequently propelled to engage in the creation of new knowledge and innovative solutions. This approach is particularly important in an applied field, where both practitioners and scholars are heavily engaged with real-world issues. Using this overarching philosophy, I have made contributions in terms of classroom teaching, formal and informal mentoring of undergraduate and graduate students, and hands-on teaching through participation across my funded trials. I have also mentored students through the Summer Research Opportunity Program (SROP) and the UIC Honors College. At the UIUC School of Social Work, I have taught two courses at both the undergraduate and graduate levels: Social Work Research Methods (SOCW427) and Human

Behavior in the Social Environment (SOCW451). Finally, from 2016-2022, I served on the Minorities Committee of the American Heart Association and my activities as peer reviewer traverse both scientific societies and academic journals.

I am grateful for the opportunity to submit my application for consideration for the position of Associate Professor at the UIC Department of Kinesiology and Nutrition. As is demonstrated in my CV, I have worked closely with my colleagues in Kinesiology, across both the Chicago and Urbana-Champaign campuses, including Drs. David X. Marquez, Ken Wilund, and Neha P. Gothe. I have served as member of multiple dissertation committees for PhD students enrolled at the UIUC Department of Kinesiology and Community Health. I also have extensive collaborative ties with faculty of UIC, across departments in Nursing, Public Health, and Nephrology, among others. As such, I look forward to meeting members of the search committee to provide further details of my research portfolio and future goals, along with my commitment to teaching and mentorship.
